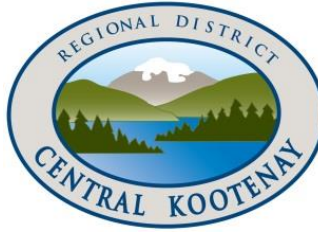

4. RECEIPT OF MINUTES

The February 4th, 2025 Riondel Commission meeting minutes, have been received.

5. PUBLIC TIME

- Question: Has the ferry issue been addressed by the RDCK?
 - Director Jackman responded that the RDCK has responded to this urgent matter and continuous pressure for a resolution is being applied.

6. OLD BUSINESS

6.1 Chair Panio provided the Commission with an update on Waste Management research and Garbage sticker price increase including:

- Chair Panio read Ulie Wolf, Regional Manager of Environmental Services letter in regarding potential costs involved in researching alternative waste management options and seeking approval for changes. The Commission did not recommend any further action at this time.
- Director Jackman noted we are not sure if the Recycling will be maintained in Riondel; it has been recommended to be shut down. Director Jackman requested it not be shut down this year. Waste Management & Recycling are two separate contracts.
- RDCK Board o approved the increase of garbage sticker costs to \$4 as of March 1, 2025, official notices will be posted.

6.2 Chair Panio provided the Commission with an update on the expanded activities at the Riondel Community Centre, new programs and an update on insurance including:

- Chair Panio advised that Maintenance personal are working at upgrading the women's washroom.
- Wendy Miller, Treasurer of the Riondel Community Association advised that the Association has purchased General Liability Insurance; we have included the Art Room and Band Room.

- Wendy Miller, Treasurer of the Riondel Community Association updated the Commission on the status of the subcommittee researching the upgrades of the current auditorium kitchen to a commercial kitchen.
- Director Jackman reported on ongoing negotiations between RDCK and Columbia Basin Trust about possible funding for major Community Centre upgrades.

6.3 Chair Panio provided a verbal report on the Riondel Water Service Community Advisory Meeting held on February 5th, 2025, including:

- Forthcoming installation of missing sections of water line on Ainsworth Avenue
- Installation of emergency generator at water treatment plant
- Further upgrades to the plant and reservoir
- Potential impact of removal of Riondel Golf Course from the water service.

7.1 Occupancy Load

Chair Panio lead the Commission in a discussion on the Occupancy Load Numbers for the Community Centre including:

- Maximum Occupancy signage is now up in the Activity Room, Auditorium and stage area.
