Community Energy Transformation (ACET) backstopping the geothermal permit acquisition. ACET has already put the Kootenay Lake Geothermal Project on their radar. At this time the Kootenay Lake Geothermal Project will be applying to have one geothermal permit.

Open houses for the Kootenay Lake Geothermal Project in Crawford Bay February 11th and Riondel February 25th.
