5. OLD BUSINESS

5.1 Kootenay Lake Ferry Strike

5.1.1 Survey Results

The recent survey created by an anonymous member of the public was completed by nearly 300 people in the ferry strike effected areas. Over 52% of responses were gathered from public on the east shore of Kootenay Lake. The survey will run again in April to gather additional data from businesses and members of the public affected by the ferry strike.

5.1.2 Collaboration Discussion

Members of the Kootenay Lake Chamber of Commerce joined the Commission to discuss the ferry strike. Concerns from public that are suffering harm as a direct result of the ferry strike need to be detailed and shared with provincial contacts. The Commission would like the Labor Relation Board (LRB) and BC Minister of Labor to understand the level of harm that the strike is causing.

The Commission and Kootenay Lake Chamber of Commerce are going to gather a list of maintenance concerns with the vessels for the Glade, Harrop and Kootenay Lake routes. Any items of concern will be shared with the BC Minister of Transportation and Transit.

Kootenay Lake Chamber of Commerce has a new board, and the focus of the new board is community communication. The Chamber have had several successful public information sessions that have been well attended. The Chamber is just starting their membership drive for 2025.

5.2 Kootenay Lake Geothermal Update

The South Kootenay Lake Community Services Society were successful with their Rural Economic Diversification and Infrastructure Program (REDIP) application for funding to support the Geothermal project. The project team are currently reviewing the existing program plan including work with Selkirk College and College of the Rockies and have proceeded with student interviews. They are also preparing for a thermal survey over the Ainsworth area and a drone magnetometer survey in the Riondel area. Commissioner MacMahon has a meeting with a representative from Accelerating Community Energy Transition (ACET) to discuss potential funding options for the project through the ACET program.

Commissioner MacMahon answered the Commission's questions.
